Can You Dig It?



An underground utility line is **damaged once every 9 minutes** because someone didn't call 811.



Call 811, the "Call Before You Dig Number," at least **2 business days** prior to digging.



811 locators **do not detect** underground sprinkler systems, invisible fences, data communication systems, private water systems, or gas piping to a garage.



Even if you have previously had underground utilities marked, **utilities can shift**, so it's best to call before starting a new project.



Once **all of your utilities** have been located, then you can start your digging project!

New Year's resolution: Be energy efficient year-round

Seal in comfort and savings

As energy consumers, we can all play a part in conserving resources and reducing our bills. Here are some practical tips to boost your home's energy efficiency throughout the year.

Know your energy consumption

Start by reviewing your energy bills for the past 12 to 24 months. Calculate your average monthly usage to establish a baseline for measuring your energy-saving efforts.

Adopt no-cost ways to save energy

Small changes can lead to significant savings:

- Turn off lights and unplug electronics such as chargers when not in use.
- Close or lower window coverings to regulate the temperature indoors.
- Change your air filters regularly as recommended.
- Use ceiling fans strategically — counterclockwise in summer and clockwise in winter to force warm air down.
- Grill outdoors during the summer to keep heat out of the kitchen.

Insulate your home

Weatherproofing is key to maintaining comfort and reducing energy use:

- Check for air leaks around windows and doors using the wet finger or tissue test.
- Apply caulk or weatherstripping to prevent drafts.
- Remember to keep doors closed to maintain indoor temperature.

Optimize your heating and cooling by using your programmable thermostat's features — many homeowners never use them — and allow it to adjust the temperature when you're asleep or away.

- Consider upgrading to a smart thermostat for automatic adjustments.
- In general, adjust the thermostat a few degrees up or down for energy savings.
